## **Emissions Reduction Targets**

In order to continue our progress to achieving Net Zero, ESP have implemented the following carbon reduction targets;

- To carry out annual reviews of the published Carbon Reduction Plan.
- To meet the objectives of the Carbon Reduction Strategy.
- To progress the actions on the Carbon Reduction Action Plan.
- To utilise technology to understand emission usage better.
- To switch to renewable energy.
- To reduce consumption and waste.
- To use sustainable suppliers.
- To maximise opportunities to offset emissions.

We project that carbon emissions will decrease from the baseline emission figures, by 34.9tCO2e, by 2027. This is a reduction of 18%.

## **Carbon Reduction Projects**

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline.

- Implementation of an Environmental Management System, certified to ISO 14001.
- Implementation of an Environmental Improvement Plan.
- Completed the move from two offices in Hull to one office.
- Replaced boiler in the Arbroath office.
- Enhanced our working from home offering, reducing the number of employees commuting.
- Timed shutdown/ startup of equipment every evening/ morning.

In the future we hope to implement further measures such as:

- Installing solar panels at our Arbroath office.
- Installing electric car charging stations at both offices.
- Implementing consumption and waste reduction measures.
- Continuing to upgrade equipment to more energy efficient versions.
